- (1) The "Contract Rates" are available to any Shipper that has executed a Transportation Services Agreement ("TSA") with Carrier on or before March 30, 2025, pursuant to which such Shipper has agreed to ship, or otherwise pay for not shipping, a minimum volume of 40,000 Barrels per day from any combination of the Origins listed in this tariff to any combination of the Destinations listed in this tariff for a minimum term of seven years (such shipper referred to as a "Committed Shipper"). Shippers that are not Committed Shippers and therefore do not qualify for the Contract Rates specified herein, may ship volumes from the above-noted Origins to the above-noted Destination via the applicable published Bridger local tariffs.
- (2) Based on total barrels shipped by a Committed Shipper in the month, divided by the number of days in such month. For example, if a Committed Shipper ships 1,200,000 barrels in a 30-day month, such Committed Shipper will be deemed to have shipped 40,000 barrels per day, on average, during such month. The Committed Shipper shall be assessed the rate of 257.15 for the first 12,000 barrels shipped each day of the month, and a rate of 205.00 for the remaining 28,000 barrels shipped each day of the month.

Notwithstanding the foregoing, Shippers that deliver into Tallgrass Pony Express Pipeline, LLC's ("Tallgrass") pipeline system at the Bridger Guernsey HUB, Platte County, Wyoming for further transportation to the applicable destination points on the Tallgrass system under Bridger's F.E.R.C. No. 123.28.0 and subsequent reissues thereof, shall not be subject to the additional pumpover rate set forth in Bridger's F.E.R.C. No. 129.13.0 and subsequent reissues thereof that would otherwise apply to movements from the Bridger Guernsey HUB to Tallgrass's pipeline system in Platte County, Wyoming.

[N] Pipeline Loss Allowance

Each shipper moving under this tariff shall pay a pipeline loss allowance of 0.20% for transportation from any Origin to any Destination.

[N] Prorationing

To the extent Bridger receives nominations for transportation under this tariff that exceed available capacity, such nominations shall be subject to prorationing pursuant to Item 76 (Prorationing) of Bridger's rules and regulations tariff, F.E.R.C. No. 26.21.0 or subsequent reissues thereof.

Shippers that are not Committed Shippers, and therefore do not qualify for the Contract Rate specified herein, may ship volumes from the above-noted Origins to the above-noted Destination via the applicable published Bridger local tariffs.

Pipeline Loss Allowance

Each shipper moving under this tariff shall pay the pipeline loss allowance applicable for each line segment comprising shipper's combined movement upstream of Guernsey Station, as such pipeline loss allowance shall be specified in the local Bridger tariff governing local service on such line segment.

Prorationing

To the extent carriers receive nominations for transportation under this tariff that exceed available capacity, such nominations shall be subject to prorationing pursuant to Item 48(e) (Expansion Capacity Prorationing Procedures) of Bridger's rules and regulations tariff, F.E.R.C. No. 112.30.0 subsequent reissues thereof.
