Note [1]: Subject to the provisions of Item No. 21, a charge of [U] 22.68 cents per barrel will be levied, in addition to any line-haul rate and other applicable charges stated in the tariff, for the transportation of a Light Sweet, or LS, stream as a segregated batch.

Note [2]: In addition to the transportation rate and all other lawful rates and charges, each shipper shall pay a [U] 37.76 cents per barrel charge for the use of a Drag Reducing Additive, which will be supplied and injected by the pipeline.

[N] Note [3]: A gathering charge of 41.42 cents per barrel will be applied to any crude oil barrels gathered at the following locations in Fallon County, Montana: (1) Pennel WF Unit, (2) Monarch Field, and (3) Coral Creek Sec 4. An additional surcharge of 91.81 cents per barrel will be applied to all barrels gathered at Monarch Field. The surcharge shall apply to such barrels beginning June 1, 2019 until Bridger Pipeline LLC collects the surcharge on a total of 600,000 barrels.
